Section A: Introduction

This manual contains a description and instructions for this DSD product. Operating instructions are included for the features added by this product to Sage 100. For instructions on using Sage 100, refer to the appropriate Sage 100 manual, or call your Sage 100 reseller. DSD Business Systems offers excellent Sage 100 support, at an hourly rate.

A/R Deferred Revenue Posting Features

This enhancement allows future Revenue and Deferred Postings to the General Ledger to occur during the A/R Invoice Update. A/R Invoice Data Entry has been enhanced to have two new fields: Number of Months and Start Date. When these field values are entered by the user, future postings will occur on the same day each month, for the number of months specified, for each Miscellaneous Line Item that has a Deferred Revenue Account setup in Miscellaneous Item Maintenance.

During A/R Invoice Update, if a Deferred Revenue Account exists in Miscellaneous Item Maintenance for a Miscellaneous Line Item, then the posting to Revenue that would normally occur is changed to post to Deferred Revenue, for the Posting Date. Future postings are then created as follows:

- Debit to the Deferred Revenue Account for that Item as set up in Miscellaneous Item Maintenance.
- Credit to the Revenue Account for that Item as set up in Miscellaneous Item Maintenance.

The amount posted for the "future" Debit and Credit are the Line Extension divided by the Number of Months.

This enhancement is beneficial to companies that sell Support Contracts or Maintenance Plans. The objective is to credit the overall Contract/Plan amount to Deferred Revenue for the Posting Date, and then credit Revenue and debit Deferred Revenue in future months.

This product works best when there is a dedicated Miscellaneous Item for Support Contracts or Maintenance Plans set up with a Deferred Revenue Account.

A new History file has been created that is posted to when each "future" G/L Posting is posted. This file contains one record for Year/Month/ItemCode/InvoiceNumber/Sequence. This allows a Crystal Report to be created to report deferred revenue forecasting.



Section B: Getting Started

Important – Read this section prior to installing this enhancement.

Updated Modules

This enhancement modifies several Sage 100 modules. If you reinstall one of the Sage 100 modules listed in the following table, you must also reinstall this enhancement. Enhancements from different Sage Tech Partners may not be designed to work together.

If you are upgrading Sage 100 with a Product Update, check the DSD website for compatibility before upgrading. A new version of the enhancement may be required.

If you are upgrading Sage 100 to a new version (e.g., 2021 to 2023), you must obtain the latest compatible release from the DSD website prior to installing and converting.

Ensure the compatibility of all enhancements with the version being upgraded to prior to starting the installation process. Work with your reseller to ensure that enhancements are compatible with each other and note the proper order in which they should be installed.



Installation

Back-up: Exit all Sage 100 sessions. Back-up existing Sage 100 data.

Check Levels: Sage 100 module levels must match those listed above.

Run Enhancement Setup Program: Save the executable installation program (sent to you or downloaded from our website) in a convenient location on the Sage 100 server. Launch the program from Windows Explorer or by selecting Start/Run, and then browse for the file in the location you saved it. Follow on-screen instructions.

Send your Sage Serial Number to your DSD Representative: Send your Sage Serial Number to your DSD representative in order for us to send you back the encrypted keys to unlock your system. This serial number can be found in Library Master\Setup\System Configuration, Tab 3. Registration as Serial Number.

Re-Start Sage 100: Sage 100 will be updated.

Update Security: After installation, you may not see the modules you installed on the Launcher menu. You will need to update all your security Roles to include access to the newly installed modules. Make sure your user has sufficient rights to modify Role Maintenance and add access to the new DSD enhancements to the appropriate Roles.



If this is your first DSD enhancement, make sure to add the DSD Enhancement Control Panel in the Library Master module to an appropriate Role.

Run the DSD Enhancement Control Panel: Run the DSD Enhancement Control Panel from the Library Master module under the Utilities menu.

DSD Enhancement Control Panel

Starting with version 3.61, all DSD Enhancement products include DSD's Enhancement Control Panel. The DSD Enhancement Control Panel is accessed from the Library Master Utilities menu.

The DSD Enhancement Control Panel is a simple to use yet powerful system to help maintain DSD Enhancements installed on a Sage 100 system. To use it, select an Enhancement product from the list on the window and then click the button, on the right side of the window, which corresponds with the desired task.



View Manual: This button will display the product manual for the selected Enhancement using Adobe Acrobat. For this to be possible, the PDF file for the corresponding manual must be in the "MAS90/PDF" folder in the Sage 100 system. If the file is not present, and the system has web access, the correct PDF file will be automatically downloaded from the DSD website, put into the "MAS90/PDF" folder and then displayed.

Check the Web for Updates: This button will check the DSD website to see what the current build is the selected Enhancement and

alert the user if a later version is available. This requires an internet connection on the Sage 100 system.

DSD Enhancement Control Panel

Unlock Product: This will cause the DSD Enhancement License Agreement and Activation window to appear. DSD Enhancements must be unlocked to run. When any part of the Enhancement is run for the first time, the DSD Enhancement License Agreement and Activation window will appear. Follow the steps shown on that window. You can click the Help button for more detailed instructions. *This button is disabled if the selected Enhancement is already unlocked or if unlocking is not required.*

Enhancement License Agreement and Activation window, click on the Agree button to accept the DSD License Agreement. After accepting the License Agreement, you can then select the type of unlocking that you'd prefer. The choices are File, Web, Demo and Manual Entry.

File Unlock: After receiving your encrypted serial number key file from DSD, and placing that file in the MAS90/SOA directory, selecting this option will unlock all products keys contained in the file. This means you can unlock all enhancements at once using this option.

Web Unlock: If the system that is running the DSD Enhancement has web access and you have sent DSD your Sage Serial number, you can unlock the Enhancement without assistance using



Web Unlock. When this option is selected, the licensing program will attempt to download encrypted serial number key file from DSD and then proceed to unlock all enhancements contained in the file.

Demo Unlock: If a Demo mode is available for the Enhancement you're running, you will be able to Demo unlock the product without assistance from DSD for demo purposes.

Creating a Demo Unlock is a good way to temporarily unlock DSD Enhancements off-hours, if you do not have web or email access. Later, you can unlock the product fully, during business hours.

Manual Entry Unlock: If you want to unlock a single enhancement using a single encrypted key, you can select this option and enter the 64 character key you receive from DSD by copy and paste.

Unlock All Products: This will cause the DSD Enhancement All License Agreement and Activation window to appear. This window is similar to the one described on the previous page but has only web and file as options to unlock. *This button is never disabled.*

Convert Data: After verification, the selected Enhancement's data conversion program will run. Data conversion is non-destructive and may be triggered any number of times. Sometimes this is required to fix data records imported or updated from a non-enhancement installation.

Help: The Help button, located at the bottom right of the window, opens an HTML help file.

Get Adobe Acrobat: Opens the Adobe Acrobat website to the page where Acrobat can be downloaded and installed.

Uninstall Enhancement: If this option is available, then selecting this button will start the un-install process, removing the enhancement from the system. For more information see <u>Uninstall DSD</u> <u>Enhancements</u>.



Section C: Setup

Miscellaneous Item Maintenance

Miscellaneous Item Maintenance has been modified to include a new G/L Account Field for Deferred Revenue postings as well as a field for Contra Revenue Postings.

Note: If a Deferred Revenue Account is not assigned to an Item Code, it will not post to deferred revenue.

Note: The Contra Revenue Account is optional. If there is no account assigned for Contra Revenue Deferred Revenue postings will still occur. If a Contra Account is assigned, Contra Revenue postings will be made in addition to the Deferred Revenue Postings.

Section D: System Operations

A/R Repetitive Invoice Entry

Two new fields have been added to the Totals Panel in A/R Repetitive Invoice Entry: **Number of Months** and **Start Date**. If these fields are left
blank> by the user, then no deferred postings will be transferred to the AR Invoice. If the Number of Months field is set but no Start Date is entered on the Repetitive Invoice, the Selection Date from Repetitive Invoice Selection will be used as the newly created Invoice's Start Date.

If these fields are left <blank> by the user, then no deferred postings will occur.

If the user enters values into these fields, the A/R Invoice Update will post **additional postings** for each Item Line that has an associated Deferred Revenue Account set up.

A/R Sales Journal Update

G/L Postings

If the user enters values into the **Number of Months** and **Start Date** fields on an Invoice, the A/R Invoice Update will post **additional postings** for each Regular Item Line.

The "standard" General Ledger posting will still be posted: a debit to A/R and Cost of Goods, and a credit to Inventory and Sales. The account posting to Sales comes from the Sales Account in Miscellaneous Item Maintenance. If you also have an account set up for **Deferred Revenue** in Miscellaneous Item Maintenance, then the amount posted to this account will be the full Extension of the Invoice Line. All of these postings will post on the date that you have set for the Posting Date.



The "Additional/Future" postings will start based on the **Start Date** field on the invoice, and will reoccur on the **same day** each month following based on the **Number of Months** field on the invoice. The accounts that are posted to are as follows:

- Debit to the Deferred Revenue Account for that Item Code
- Credit to the Sales Account for that Item Code

The amount posted for the "future" Debit and Credit are the Line Extension divided by the Number of Months.

For example: You create an invoice with one line item for \$600, and you enter 6 as the Number of Months and the Start Date is 2/1/2016. The Posting Date is 1/15/2016. The Cost on that item is \$250.

Note that the Amounts posted are the Extension (\$600) divided by the Number of Months (6) and that the Posting Dates are on the **same day** in each subsequent month.



NOTE: The same Source Journal ("AR") and Batch Number will be used for future postings.

G/L Postings with Contra Account

If the user enters values into the **Number of Months** and **Start Date** fields on an Invoice and a Contra Account is assigned in the Miscellaneous Item Maintenance, the A/R Invoice Update will post **additional postings** for each Regular Item Line and will also post additional posting for the Contra Account as well.

For example: You create an invoice with one line item for \$600, and you enter 6 as the Number of Months and the Start Date is 2/1/2016. The Posting Date is 1/15/2016. The Cost on that item is \$250.

Here are the postings that will occur when the Contra Account is also defined :




After the Uninstall of the DSD Enhancement, you MUST reinstall certain standard Sage 100 modules, followed by reinstallation of Product Updates and Hot Fixes, if applicable.

A message box will appear, and will display which of those specific Sage 100 modules you must reinstall afterwards.

- Select No to exit the Uninstall Process.
- Select **Yes** to continue with the Uninstall Process.

The following message box will appear, displaying the final warning message.

- Select No to exit the Uninstall Process.
- Select **Yes** to continue with the Uninstall Process. At this point, the DSD Enhancement will be removed from the Sage 100 system.
