



Company and Administration

- <u>Enhanced email delivery and insights for everyone</u>: The enhanced email delivery service boosts your email security and gives you better delivery insights. This service is now available to everyone.
- Fiscal year rollover for General Ledger document sequences: Document sequences for journal entries now support fiscal year rollover to help you manage document sequences with year-end transitions.
- Usage insights show admins key metrics for customers, vendors, users, and more: Learn more about how your business is using Intacct and make better decisions based on this data.
- <u>The User information page has been streamlined</u>: We've updated the User information page to simplify your workflow, saving you time and clicks.
- <u>Barcode fonts now available for printed document templates</u>: Two Google barcode fonts are now available for use in printed document templates. Download the fonts from Google and then use them in Microsoft Word.
- Permission changes: We added new permissions for General Ledger and Order Entry.

Accounts Payable

- <u>Restricted users can void top-level payments</u>: Restricted users with top-level access can now void
 payments they create at that level.
- Unapply credits more easily: Unapply a vendor credit from the Posted payments page.
- <u>Uniform treatment for user restrictions</u>: We've updated how user restrictions are enforced when approving payments.
- Void payments more quickly: Void payments directly from Posted payments and skip the bank and check registers.
- <u>Vendor Payments for American Express is being retired</u>: Make sure to process all payments by December 20, 2024.



Accounts Receivable

• Edit discount amount: Customize the discount applied to an invoice without altering the term.

APIs and Web Services

- Check out the REST API: Now available in an Open Beta for you to try out.
- Stay up-to-date on great new Web Services features: Read the Sage Intacct Developer portal blog.

Cash Management

- Save time while reconciling: The reconciliation page now defaults to show all unmatched transactions.
- Bank transaction assistant file import: Import more file types for bank reconciliation.
- <u>Control who can view bank account information</u>: Configure Cash Management to restrict access to account reconciliation information by user restrictions.
- <u>Save time when creating journal entries during reconciliation</u>: The exchange rate posting date for a journal entry now defaults to the bank transaction date.

Consolidation

• <u>Streamlined book deletion</u>: When you want to delete a consolidation book, we delete the book and its data in the background. You can navigate away and continue working.

Fixed Assets Management

- <u>New reports for Fixed Assets Management</u>: Three new reports are now available to gain insight into your fixed assets: Net Book Value, Assets by Employee, and Assets by Location.

- **Export your TPAR**: Australian companies and entities can speed up the TPAR lodging process using a new export option.


